### **OVERVIEW**

On Wednesday April 7th 2021, Impact Philanthropy Africa held its inaugural virtual conference in Nairobi, Kenya.

Impact Philanthropy Africa is a forum of self-funded corporate and private charitable foundations working in Kenya, working to build a culture of corporate social investment (CSI) and influence policy through advocacy and thought leadership. The Impact Philanthropy Africa inaugural conference was themed Building Back Better: Growing Philanthropy Through Corporate Social Investing (CSI) in Kenya. The conference objectives were twofold:

- 1.To officially launch the Impact Philanthropy Africa forum and to orient members on the forum's vision, mission, and objectives.
- 2.To initiate discussions around understanding the environment in which local philanthropy operates and what the opportunities and challenges with regards to creating an optimal policy and legal environment for growing corporate giving in Kenya are.

#### Outcomes

Overall, the secretariat felt the conference met its objectives for this event, particularly with:

- 1) Policy optimization: the very clear steps identified for what needs to change in the legal framework governing foundations and trusts and for optimizing an enabling giving environment.
- 2) Government Engagement: Mr. Nzioka Waita accepted to facilitate a formal meeting between government and the philanthropy sector, led by Impact Philanthropy Africa. Impact Philanthropy Africa is now challenged to convene, coordinate and be the voice of the corporate and private philanthropy collective.
- 3) Catalyzing philanthropy: Having a clear call to action and anchor to invite more corporate and private philanthropies to get engaged in the Forum and support its agenda.

Impact Philanthropy Africa Forum was challenged to convene, coordinate and be the voice of the corporate and private philanthropy collective.

### Attendance

The feedback from participants was extremely positive, many considering the discussions very pertinent and welcoming further engagement with the forum. Participation was very good. In total, it was attended by 87 participants. The breakdown was as follows:

- Very high participation from the current members: There were multiple representatives drawn from 10 of 12 current Impact Philanthropy Africa member organizations throughout the virtual conference.
- Very good participation from prospective members: Multiple representatives from 6 prospective member organizations attended, namely:
  - KCB Foundation
  - Mastercard Foundation
  - UAP Old Mutual Foundation
  - Equity Group Foundation
  - Bamburi Cement Limited
  - Asian Foundation Kenya

### Attendance

- Other stakeholders: 3 philanthropic organization networks participated, as well as other consulting and partner organizations.
- **Government:** The Executive Office of the President of the Republic of Kenya in addition to providing the keynote speaker was also strongly represented. From the government side, the PDU also had a few staff members on the call.
- The event also attracted many individuals/independents from private sector, civil society, and academia.

We invited **15** media representatives to the Conference in partnership with Safaricom's media team.



We provided access to several resources during the event; with 100+ downloads. This is part of the Forum's information and knowledge-sharing efforts.


Less than 10% of event attendees completed the feedback survey.

However, the 6 responses are largely positive, and the Secretariat is conducting one-on-one interviews with participants and Forum members.






The conference sessions were of high quality




#### In what capacity did you attend the Virtual Conference?




On a scale of 0 - 10, how likely is it that you would recommend the event to a friend or colleague?




Are you likely to participate in one of Impact Philanthropy Africa events in the future?
