




Advocacy For Change (A4C) Sectoral Committees and Members List



The Summit

- Made up of the senior-most leadership in the Foundation/Company.
- The Summit to meet at least once a year.
- Summit members to hold high level meetings with Government and other key Stakeholders on issues pertinent to corporate and private philanthropy in Kenya.

The A4C Advocacy for Change(A4C) Technical Working Group

- Made up of the Forum focal points in the Foundation/Company.
- The A4C to meet at least twice a year.
- The A4C to co-create and drive the Advocacy for Change agenda for the Forum.
- The A4C to provide the technical support and briefing to the Summit.
- The A4C to have thematic committees that can delve deep into sectoral issues.


Sectoral Committees

- The A4C to have sectoral committees to drive social change in those sectors.
- Each sectoral committee to meet at least twice a year or as needed.
- The sectoral committees to provide recommendations/insights to the A4C Technical working group. These
 committees to exchange insights and best practices across relevant initiatives in that sector.
- The committees to explore advocacy opportunities for collective action that the Forum can undertake to influence both policy and practice in areas relevant to corporate and private giving in that sector.





Sectoral Committees Proposed Terms of Reference (ToR)



The A4C sector committee is composed of the Impact Philanthropy Africa Forum members drawn from the A4C TWG.

Committee tasks:

- Set the priorities for the respective sectors.
- Research into issues, trends and programs in the sector.
- Discuss issues affecting the sector and provide possible solutions. Give recommendations to the A4C TWG to forward to the Summit. Pursue opportunities for collective action.
- Represent the Forum in sector convenings and other policy engagements.

Each committee will be led by a Chairperson and a Vice-Chairperson, elected by members of the committee, from among the committee members. The Chair and Vice-Chair will lead for a term of one (1) year.

The Committee Chair will:

- 1. In consultation with the secretariat, convene committee meetings at least two (2) times a year.
- 2. Chair committee meetings. In his/her absence, delegate to the Vice-chair.
- 3. Lead /quide the committee deliberations.
- 4. In collaboration with the secretariat, collate the discussion points and present them to the A4C TWG.
- 5. Consult/work with other committee chairs to harmonize the discussions of the committees and presentations to the wider membership.
